ii) Service of Church Clock

The Parish Council entered in to a three year contract to service the Church Clock prior to the legal advice being received from the Association of Local Councils (ALC) which indicates that local councils should not give financial support to Church property. The 3 year agreement was the most cost effective means of securing the work.

The final service under that agreement was carried out in May and the Parochial Church Council have asked that the Parish Council pay the invoice. The Church has provided information to indicate that they face a financial deficit this year.

Following discussion with the Chairman and in view of the urgency of payment being made, the invoice has been paid as follows:

£202.00 plus £40.40 VAT = £242.40

11. ROADS AND FOOTPATHS

b) The BOAT, pedestrian refuge and danger to pedestrians at Wootton Lane

There is nothing further to report on these matters. However, the Clerk has approached the supplier of CCTV cameras who previously offered a free trial, with a view to trying them out at the BOAT. A response is awaited.

c) VAS (Vehicle Activated Sign)

The Council is aware that an engineer has inspected the sign which was relocated from the other end of the village but has not been working properly. The supplier reports:

"the engineer visited the sign, and couldn't find any particular fault with the sign, other than the location not being ideal for vehicles to be travelling fast enough to activate the sign.

I am unsure how to proceed, other than make a few suggestions. The sign needs to be further back if it is to catch vehicles speeding, away from the hill/bend. The other suggestion would be to replace the sign with a Speed Display Unit, like a DSD, or a Mini 300 (There is a Mini 300 at the other end of the village). This would activate at a lower speed, and we could see the vehicles activating the sign, albeit lower than the speed limit."

Moving the sign back would seem to defeat the object, which is to warn vehicles before they enter the village and approach the junction between the A442 and Wootton Lane. The present location was suggested by the supplier and by Shropshire Highways.

The Council may also recall that the existing sign did not always function properly at its original location near to the Farm Shop.

The supplier has quoted £3462.33 plus VAT of £692.47 = total £4154.80 to replace the existing sign with a Mini 300 such as in use at the other end of the village.

The instructions of the Council are requested.

d) Wootton Ford

A councillor has pointed out that the road surface approaching the Ford on both sides is in poor condition.

e) Wootton Lane to the New Barns

The Council will be aware of the very poor road surface along this stretch of road.

The Clerk has written to the landowner about water running off farmland and damaging the road surface.

Photographs of the road surface and that near the Ford have been sent to Shropshire Highways.
