It was noted that Shropshire Council had withdrawn the booking system for use of the Bridgnorth public recycling site, although domestic users still had to prove that they lived in the County. The facility was well used and the green bin recycling charges had produced good revenue for the Council.

She also reported that Shropshire Council would be collecting the election fees in the current financial year, the year of the elections, rather than the following year as had been the practice previously.

Cllr Mrs Yates also reported that the new Chief Constable of West Mercia was anxious to meet with local councils in the area covered by the Force.

b) Quatt Village Hall Committee

The Secretary of the Village Hall Committee reported that the carers days were still well supported and that a women's, safety day event was to be held. The Hall was also hosting a new theatre group and many other events, including dog training classes and wedding receptions. The new heating system was working well and other improvements were being planned, including new tables for the Committee Room.

c) Quatt Cricket Club

Councillor Mrs C.Hulland reported that the Club was still raising funds to upgrade the Clubhouse and this should be completed soon. The Club was supporting 3 local schools with a view to getting youngsters interested in the sport.
