Form to Apply for a Grant from Quatt Malvern Parish Council

Each year the Parish Council has a small budget allocation available to give as grants to local organisations or individuals to help to improve the well being of people living in Quatt.

At the meeting of 28th September 2023, Quatt Malvern Parish Council approved a new policy for awarding grants to local organizations or individuals:

i) That all local organizations are contacted in early April each year and advised that they must apply for any grant aid by November of the same year, sending all details of estimates, quotes etc., their financial position, purpose of the grant and other resources available to them.

ii) That the organizations be advised that normally any grant awarded will be of a maximum specified sum.

iii) That any applications received will be considered at the November meeting of the Parish Council and grants awarded accordingly.

iv) That the Council determine the normal maximum grant sum and determine a budget allocation for the following year at the January budget meeting.

Retrospective Applications will not be considered

Type of Grants To Be considered

- You can apply as an individual or on behalf of an organisation
- You must either live or work in the Parish of Quatt Malvern or be very closely associated with the Parish.

Your idea for a grant must be

- “To Improve the well being of all or some” of the people in the Parish of Quatt Malvern.

Number of grants to be awarded

The Council is hoping to award between three or four grants each year, subject to the limits of the fund.

When you have finished your project

We shall expect you to spend the grant within 12 months and submit a short report and statement of accounts on completion of your project.

If your grant award is not successful

We shall explain why your application was not successful and advise you about further applications.
