It was noted that the Draft Plan was still being examined by the Planning Inspectorate.

21.22.109. LOCAL ROADS AND FOOTPATHS

a) Residents' Concerns

Councillor Ms S.Hunter reported that residents in Wootton Lane were concerned at the dangerous practice of some motorists to drive at speed over the hump in the road near the Church, apparently in an attempt to make their vehicles leave the ground.

She also reported a large pothole in the road at Mose.

Resolved

That the Shropshire councillor, Elliott Lynch, be requested to arrange a site visit with himself, the Parish Council and an officer from Shropshire Highways to discuss these matters and the potholes issue raised at minute 21.22.099 above.

b) Proposed Pedestrian Refuge

It was noted that South Staffordshire Water had acknowledged the request for financial assistance made by this Council and were giving it their consideration.

<u>Resolved</u> that the Clerk chase the Company for an update on the request.

c) Local Cycling and Walking Infrastructure Plan - Shropshire

The information about the proposed Infrastructure Plan and the consultation was received and considered.

Resolved

That Quatt Malvern Parish Council request that a pedestrian refuge to assist pedestrians to cross the A442 at Quatt be incorporated into the Plan, as part of the footpaths network in the Parish.

d) Survey of Rights of Way

The information from the Shropshire Council Rights of Way Officer was received and noted.

<u>Resolved</u> that the Clerk try and obtain a copy of the Definitive Map which related to Quatt Malvern Parish.

21.22.110 REPORT OF THE SHROPSHIRE COUNCILLOR

Councillor Elliott Lynch was not present at the meeting and there was no report from Shropshire Council.

<u>Resolved</u> that the Clerk request Councillor Lynch to provide a written report if he was unable to attend meetings of the Parish Council.

21.22.111. NATIONAL TRUST REPORT

Marcus Halliwell reported that the snowdrop weekends would commence soon and that the gardens at Dudmaston would be open from early March. The House itself would be open from towards the end of that Month. A new sculpture by locally based artist Anthony Twentyman "The Blade "was to be displayed. The appointment system for visits to the House might be continued, even although the Covid 19 restrictions had been relaxed.

It was hoped that subject to planning consent, a new path would be constructed to link the Sawmills with the Pools. The Hebridean sheep had settled in well at the Dingle.

The problem of trespass and damage to the Estate by 4x4 vehicles seemed to have declined and the Trust were grateful to everyone who had helped to report incidents of this kind.

Marcus confirmed that Helen Ralls had been appointed as the Area Ranger to replace Mike Annis.

21.22.112. PARISH AMENITIES

a) Tennis Courts at the Dower House

It was noted that the condition of the Tennis Courts and the offers of assistance to the Cricket Club from the National Trust and from the Parish Council had been conveyed to the officers of the Club.

b) Church Clock

It was noted that the Parish Council were agreed in principle to fund the works to the Church Clock but subsequent legal advice suggested that such expenditure might be unlawful.

It was not considered practicable to transfer ownership of the Clock to the Parish Council as it was an integral part of the Church building to which the Parish Council had been advised that they could not legally offer financial support.

<u>Resolved</u> that Councillor Hulland discuss the situation with the Hereford Diocese.

c) Website

<u>Resolved</u> That Councillor Ms S. Hunter circulate a list of suggested improvements to the Website.

21.22.113. REGISTER OF ELECTORS

There were currently 196 electors on the Register.

The Clerk reported that householders could now order a wheelie bin instead of the boxes presently provided for recycling. The new bins

were available free of charge and could be used to hold plastic, metal and glass items.
