# c) The BOAT

Following the last meeting, the Clerk has made contact with Alveley Parish Council. The Parish Paths co-ordinator for Alveley and Romsley Parish has expressed concern about BOATS in that Parish also and other issues concerning rights of way. He suggests a joint approach.

An extract of his message is attached to this agenda together with a message from the Green Lanes Association (GLASS) and a letter from that organization.

It is suggested that the Clerk arrange a Zoom meeting between all of the interested parties and an appropriate officer from Shropshire Council to discuss the issues and possible solutions.

### d). Survey of Rights of Way

At the last meeting, the Clerk undertook to find the definitive map relating to Quatt Malvern Parish. It is difficult to produce a satisfactory printed version of the map but it can be accessed online at
