Could the council discuss the provision of solid double white lines along that stretch, as it is a hot spot for overtaking and with the turning to the woods there are risk factors to take into account. Also could the council discuss additional signage with the National trust, so drivers are alerted sooner to the entrance of the woodland visitor attraction."

Councillor Colin Taylor, the Shropshire Council representative, said that he would support any measures to reduce speed and enhance road safety on the A442 but the Unitary Authority had very little money to spend on these measures.

Marcus Halliwell confirmed that the National Trust would support double white lines at the location in question.
